| <p><b>1.</b> The title of these regulations is the Doorstep Contracts Salesmen (Licences) Regulations.</p>  | Title.                                |
| <p><b>2.</b> In these regulations, unless the context otherwise requires - "Act" means the Doorstep Contracts Act;<br/>"Department" means the Department of Consumer Affairs;<br/>"Director" means the Director of Consumer Affairs.</p>  | Interpretation.<br>Cap. 317.          |
| <p><b>3.</b> An application for the issue of a licence to act as a doorstep contracts salesman shall be made to the Director on a form which shall be obtained from the Director, and shall contain all the particulars stated in the said form, and be accompanied by all the documents indicated on the form.</p>   | Applications for licences.            |
| <p><b>4.</b> There shall be charged by the Director, for the issue or renewal of a licence to act as a doorstep contracts salesman, a fee of twenty liri.</p>   | Licence fees.                         |
| <p><b>5.</b> The licence to act as a doorstep contracts salesman shall be in the form as set out in the First Schedule.</p>   | Form of licence.                      |
| <p><b>6.</b> (1) A doorstep contracts salesman duly licensed in accordance with the Act, shall at all times during which he is making use of such licence carry with him an identity card which shall be issued by the Director.</p> <p>(2) The identity card referred to in subregulation (1) shall be in the form as set out in the Second Schedule and shall be shown by the salesman to the consumer, at the request of the latter.</p>   | Identification of salesmen.           |
| <p><b>7.</b> Applications for the renewal of licenses to act as doorstep contracts salesmen shall be made to the Director on a form which shall be obtained from the Director, and shall contain all the particulars as stated in the said form, and be accompanied by all the documents indicated on the form.</p>   | Applications for renewal of licences. |
| <p><b>8.</b> (1) Where after an issue or renewal of a licence to act as a doorstep contracts salesman, there occurs a change in the particulars as set out in the relative application form, the holder of the licence shall forthwith notify the Director of the change in particulars.</p> <p>(2) The Director may, where applicable, require the holder of the licence to surrender his licence and identity card, and shall note the change of particulars in the licence and identity card of the licensee, and return the same to the licensee.</p> | Change of particulars.                |

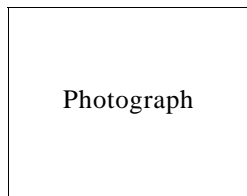
